#### 课程主旨:

本课程是面向经济学研究生的专业课程,介绍和讨论当代政治经济学的前沿 文献和研究方法。通过文献阅读和论文展示,建立对于政治经济学基本理论体系 和分析框架的认识,掌握政治经济学的研究方法,完成初步的研究设计。本课程 的文献侧重与国家发展、国家能力和治理问题相关的专题,同时对于政治经济学 的博弈论建模、社会科学因果识别方法亦有涉猎。

#### 课程要求:

本课程的教学方式以专题讲授(lecture)和论文讨论(seminar)穿插进行。选课 的学生需要完成至少一次时长为 30 分钟的指定论文展示,并在期末提交一篇与 政治经济学相关的课程论文。需要在期中之前确定课程论文的选题并提交 500 字以内的研究大纲。
